- **Eligibility:** Real time and batch eligibility checks with over 2000 payers; that can be integrated into your system
- **Coverage Discovery:** 1000 self pay claims recovers 30%
- **Deductible Monitoring:** Pauses claim then sends once a deductible threshold has been met
- **Claim Status:** Real-time claim status up to 400 payers
- **Retro Medicaid:** Search for active coverage monthly until active coverage is located OR the payor no longer allows the transaction; this can be due to timely filing.
